Obtain forms, instructions and publications, 24 hours a day, 7 days a week, by calling:

Walk-In

Pick up certain forms, instructions, and publications at many post offices, libraries, and IRS offices. Some IRS offices, libraries, grocery stores, copy centers, and office supply stores have an extensive collection of products available to photocopy or print from a CD-ROM.



CD-ROM

Order IRS Publication 1796, *Federal Tax Products on CD-ROM*, and obtain:

- Current tax forms, instructions and publications
- Prior-year tax forms and instructions
- Popular tax forms which may be filled-in electronically, then printed out for submission
- Internal Revenue Bulletins
