Life Cycles

Life cycles, web-based information tools, are available for sections:

- ▶ 501(c)(3) private foundations and public charities,
- ▶ 501(c)(4) social welfare organizations,
- ▶ 501(c)(5) labor organizations, agricultural and horticultural organizations, and
- ▶ 501(c)(6) trade associations and other business leagues.

Each life cycle includes links to explanatory information and provides a graphical snapshot of five stages organizations typically go through:

- ▶ starting out,
- ▶ applying for exemption,
- ▶ filing requirements,
- ▶ on-going compliance issues, and
- ▶ significant events, such as changes in operations, the examination process or terminating operations.

Search for Charities

Donors and exempt organizations can verify an organization's eligibility to receive tax-deductible contributions online through Publication 78, Cumulative List of Organizations Described in Section 170(c) of the Internal Revenue Code.

Published Guidance

Click on "Published Guidance" to access revenue rulings, revenue procedures, and other technical items of interest to exempt organizations and their representatives. The "Published Guidance" page also features links to the IRS written determinations, the Electronic Reading Room, the Internal Revenue Manual, and the Internal Revenue Bulletin.






