## More and more taxpayers e-file. Shouldn't you?

### Why did 72 million people e-file last year?

- **Accuracy** - *e-file* greatly reduces the chance of getting a notice from the IRS.
- **Security** - Your privacy and security are guaranteed.
- **Fast Refunds** - You get your refund in half the time, even faster with Direct Deposit.
- **Proof of Acceptance** - You receive an electronic acknowledgement within 48 hours that the IRS has accepted your return for processing.

### Electronic Payment Options

- You can e-file your federal income tax return (Form 1040, 1040A, or 1040EZ) and, at the same time authorize an electronic funds withdrawal from your checking or savings account. You can also pay by credit card.
- There are no additional charges for electronic tax payment transactions.
- You can e-file your return early and schedule your withdrawal or credit card payment for a future date up to and including April 16, 2007.

### Did you know....

- More than half of all taxpayers will file electronically this year.
- You can create your own five-digit Personal Identification Number (PIN) to sign your return electronically.
- Thirty-seven states and the District of Columbia allow taxpayers to file their federal and state returns electronically at the same time.

## Step 1 - Get all your tax information together

You'll save time and won't have to stop in the middle of preparing your return to find a missing document. Here is some of what you'll need:

- Social Security numbers for yourself, your spouse, and any dependents,
- W-2 forms from all employers are required for yourself and your spouse,
- 1099 forms for Dividends, Retirement, or any 1099 forms with Income Tax Withholding,
- Receipts for expenses for Itemized Deductions (Schedule A),
- Bank Account numbers (for a fast refund, or to pay electronically).

## Step 2 - Choose the e-file method that works for you:

- Tax Professional
- Personal Computer
- Free File

## Step 3 - e-file

■ **Tax Professional** - If using a Tax Professional, be sure to take all your information with you, and don't forget to ask for e-file. Go to [irs.gov/efile](http://irs.gov/efile) to find an Authorized IRS e-file Provider near you.

■ **Personal Computer** - Just answer the simple questions in your tax preparation software, and the software will do the rest for you. There may be a modest fee for e-file. For faster refunds, or to pay when YOU want to, have your bank account number handy.

■ **Free File** - Check [www.irs.gov/efile](http://www.irs.gov/efile) to see if you meet eligibility requirements.

**NOW RELAX. You're done.**

**And tell a family member or friend that e-file is the smart way to file their federal and state income tax returns.**
